Articles will be reviewed and will be included in Summer School proceedings in case of positive reviews.. *For citation, please use the Harvard style [also known as the author-year-style or parenthetical referencing] If possible, please do not use footnote.*

## Introduction

The article can exceed 8 pages (Deshpande, 2015). It must be of A4 format taking into consideration the following parameters: text editor – *Word*, typeface - *Times New Roman*, font size – 12 pt, line pacing - *single*, text must be placed in one column, placement of paragraph – Justified, left side – 25 mm, right side – 25 mm, upper margin – 25 mm, lower margin – 25 mm.

The structure of the article: heading, author, organization s/he represents, abstract, list of key words, body of the article (*introduction, aim, materials and methods, results, summary*), summary [*in Polish language*], list of literature, information about the author [*in the English language*] (Itagi, et al., 2015).

<b>List of keywords</b>	Title “ <b>Keywords</b> ”;	Times New Roman, Bold, 10 pt
	The list of keywords shall be alphabetized; Length – shall not exceed 2 lines.	Times New Roman, <i>Italic</i> , 10 pt
<b>Body of the article (introduction, aim, materials, research methodology, results)</b>	Title names must be highlighted (Bold) and centred. All figures, tables and other objects must be placed in the text. Titles of figures with the corresponding numbers shall be placed below the figure (for example, Figure 1. Title). The titles of tables with the corresponding numbers shall be placed above the tables - <i>Align Left</i> (for example, Table 1. Title).	Times New Roman, Normal, 12 pt, Text in the table – 11 pt

<b>Summary</b> (for translation into Polish language)	Title “ <b>Summary</b> ”	Indent 1.27cm, Times New Roman, Bold, 10 pt
	If the publication is in the English language	Times New Roman, 10 pt; Length 800 – 1000 characters
<b>List of literature and other sources Bibliography</b>	Title “ <b>List of literature and Bibliography</b> ”	Times New Roman, Bold, 10 pt, centred
	Numbered list of literature; Apply APA style, look for examples below.	Times New Roman, Normal, 10 pt
<b>Information about the author</b>	In the English language: name, surname, concentrated in the most important biographical facts on the scientific, academic and professional activities (see sample example).	Times New Roman, Normal, 10 pt, 300 – 350 characters

There should be one space between two parts of the report.

Reference – author’s surname (with no initials), year of publishing and applied pages of the book of the used literature shall be put in brackets. Notice – full stop shall be put only after the brackets. Example, (Pegler, 2003: 46).

**Two authors’ book:**

Author, A., Author, B. (Year of Publication). *Title of work*. Publisher City , State: Publisher.

Author, A., Author, B., & Author, C. (Year of Publication). *Title of work*. Publisher City , State: Publisher.

**E-book from an e-reader**

Author, A.A.. (Year of Publication). *Title of work* [E-Reader Version]. Retrieved from <http://xxxx> or [doi:xxxx](http://doi:xxxx)

**Book found in a database**

**Article in a magazine:**
